

#### School of Shari'a Description

#### For Bachelor's Degree program in the Jurisdiction and its Foundation

0402100 Islamic System

(3 Cr. Hrs.)

Definition, characteristics of the Islamic system, differences between the Islamic system and other secular systems, system of religious observances, system of the ethics; political system; economic system; social system; Islam and the actual situation of Muslims.

0452111 Jurisprudence of Purification, Prayer and Fasting

(3 Cr. Hrs.)

Introduction to jurisprudence doctrines; their founders and their methods of deduction; definition of Fiqh; purity; ablution; washing; types of water; menses; prayers; prayer of travelers, Friday prayer, prayers of feasts; prayer of the sick; funeral prayer. Jurisprudence of Fasting; definition; pillars of fasting; its time; I'tikaf, definition and conditions.

0402113 New Issues In Worship

(3 Cr. H.)

This course aims to discuss certain new issues in worship, which were not discussed before. It aims also to give the student the skills how to deal with these issues according to Jurists' manners in reasoning, and to see modern Scholars' manners in producing legislations for new issues in worship jurisprudence according to their rules which depend on texts and reasoning.

0402114 Jurisprudence Theories

(3 Cr. H.)

This course discusses the concept of jurisprudence theories, their history, development, and the main works on them. It aims also to discuss some of these theories, such as: Theory of right and the exceeding in using right, the theory of urgent circumstances, the theory of contract responsibility, the theory of contract and its effect, the theory of the intention in contracts and the bases of ruling in Islam.

0402151 Introduction to Islamic Jurisprudence

(3 Cr. Hrs.)

Introduction to Islamic Fiqh; defining Islam; sources of legislation; properties of Islamic legislation; relationships between Islam and other religions; features and history of Islamic Fiqh; schools of Fiqh; introduction to some Scholars.

0402161 Sources of Rules in the Foundations of Jurisprudence

(3 Cr. Hrs.)

Introduction to Fiqh; definition, topics of Fiqh, goals of Fiqh; development; methods of writing and its classified books; rules (judgments); sources of rules (judgments); the Qur'an, the Sunna, and the Prophet's deeds.







0402164

#### Introduction to Islamic foundations of jurisprudence

(3 Cr. H.)

This course discusses the concept of the foundations of jurisprudence, the jurisprudence bases, the differences between jurisprudence and its foundations, and the linguistic fundamental bases of jurists.

0402204

#### **Education in Islam**

(3 Cr. H.)

This course aims to introduce the concepts, expressions and the sources of education, the relationship between Islam and education, the difference between Islamic education and other theories of education, particularly in the goals, characteristics and philosophy. It also discusses the styles and manners of Islamic education, and the qualities of the good teacher.

0452213

#### Jurisprudence of Oaths, Vows, Lawful and Prohibition

(3 Cr. Hrs.)

This course aims to give a general introduction to lawful and prohibition matters, the definitions, legislation and rules of Oaths, Vows atonements, sacrifice in Islam, hunting, banning, 'Aqiqah and permitting.

0442221

#### Jurisprudence of Transactions and Participations

(3 Cr. Hrs.)

This course aims to give the student an introduction to transaction (mu'amalat or mu'awadat) in Islam; selling and its regulations and conditions; choices and their conditions; illegal selling; profit making; usury and its conditions; renting; mortgage bails. It is also discusses companies and participations in Islam, kinds of companies, contracts of irrigation and agriculture.

0402232

#### The Islamic Government System

(3 Cr. H.)

This course explains the concept of state, its modern pillars, people who are liable to be consulted, loyalty, election, constitution reforming, loyal state, political liability, legislative policy, the supremacy of Islamic legislation, the styles of authority, the restrictions on the state, the constitutional punishment regarding those who rule the state.

0442241

#### **Jurisprudence of Personal Status (1)**

(3 Cr. Hrs.)

This course includes the definition of personal status rules, the marriage contract (its concept, importance, effects), the methods of canceling the marriage contract (divorce, khal', separating by judgment because of apostasy or breast-feeding or disagreement between husbands... etc. The course also includes the influences of cancelling the marriage contract, such as: 'iddah, descent, breast-feeding, nursing and payment.

0402262

### The Legal Rule and Indications (previous req. 0402161)

(3 Cr. Hrs.)

This course highlights the rules of Fiqh; the effects of the legal rules, the indications (their obvious or obscure words, the implicit and explicit indications, the text and the concept, the general and special indications).

0402264 The Science of the Foundations of Jurisprudence (for the Faculty of Law Students)
(3 Cr. Hrs.)

This course includes the introduction to the foundations of jurisprudence, the legal evidences which scholars agreed or disagreed on them, the Islamic general rules, and the linguistic fundamental bases of jurists.

0402319 Jurisprudence of Qur'an and Sunnah

(3 Cr. Hrs.)

The course aims to discuss nearly (15) different rules which were mentioned in the Qur'an or Sunnah, such as abrogation, the rules connected to Opening Chapter, reciting the Qur'an behind the Imam, rules of respecting parents, giving Fatwa, pictures and statutes, rules of limiting sight, marriage of disbelievers and the people of the book, and some rules of jihad (struggle).

0432322 Jurisprudence of Authentications and Donations (3 Cr. Hrs.)

Money orders and their conditions; reconciliation and its regulations; waqf and its regulations; donations and their regulations; farming partnership.

0402323 Jurisprudence of the Jordanian Civil Law (3 Cr. Hrs.)

The course tackles the history of the Jordanian civil law, its sources, aims and its general directions. It discusses also the personal rights and obligations; theory of general commitment; definition; naming, status in civil law; sources of commitment and their classification; voluntary and obligatory sources; contract and its effects; cancellation; illegal work; types of responsibility illegal wealth; the law and its relationship with the four sources.

0402324 Islamic Economy (3 Cr. Hrs.)

Definition of Islamic economics; significance, objectives, sources, characteristics of Islamic economy, economic problem and how to be handled, economic doctrine in Islam, possession in islam (types, system), possession restriction, possession duties, financial system and sources, protection of Islamic economy and protection of Islamic economy systems (hiba, weights and measures control judiciary and police).

0402232 The International relations in Islam (3 Cr. Hrs.)

This course shows the development of the political society from past to present, the schools of understanding international relations, the aims of war, the different jurist schools regarding how to deal with state authority, the division of the world into Islam home and call home or Islam home and war home, rules of killing and fighting, civilians' rules and rights, war effects, withdraw rules and conditions, contracts in Islam and their kinds and influences.

0442342 Jurisprudence of Personal Status (2) (3 Cr. Hrs.)

The course discusses the rules of Wills: their conditions, cancellation, different Kinds; inheritance: its kinds and distribution according to Islamic legislation.

0402353 Jurisprudence of Punishments

(3 Cr. Hrs.)

The course clarifies the general principles of punishment legislation in Islam, Kinds of penalties in Islam and conditions of each: Hudud crimes, Qisas. Ta'zir; individual rights and public restriction.

0402425 Contemporary Financial Transactions

(3 Cr. Hrs.)

The course discusses the perception of Islamic methodology in handling contemporary issues, knowledge of legal judgment of contemporary financial treatments forms such as insurance and economic issues, supporting the Islamic economic theory in face of others, characteristics of treatment system in Islam, Islamic methodology in treating new issues, study of certain contemporary problems in the financial treatments, i,e: moral rights such as: copyright and goodwill, commercial insurance and its Islamic alternative, profitability for purchasing commander, partnership ending possession, letters of deposits and financial papers (1. Bank notes: issueand alteration of value. 2. Shares, securities and cheques. 3. Drafts and goodwill.

0402433 Jurisprudence of Judicature and Evidence Methods

(3 Cr. Hrs.)

The course clarifies the definition of the Judiciary System in Islam; conditions and properties Of the judge; arbitration; judging by default; independence of the Judiciary system in Islam; witness; written documents.

0402434 The History of Judgment in Islam

(3 Cr. Hrs.)

The course tackles the definition of judgment as one of the Islamic systems, the relation between it and other foundations of state, its stages of Judicature from the Prophetic era till our new era.

0402435 The Foundations of trials and the Judgment applications

(3 Cr. H.)

This course discusses the main bases of the system of judgment, the definition of the foundations of legislative judgment and its specializations, the form of courts in Jordan, conditions of appointing judges, bases of judgment in legislative courts, kinds of decisions and how to appeal against them.

0402452 Juristic Bases

(3 Cr. Hrs.)

The course tackles the historical background about establishing the rules of Fiqh in the Islamic cage of Fiqh. The importance of rules in understanding sub-rules. Explaining each rule with illustrative examples.

0402455 Research Manners in Jurisprudence and its Foundations

(3 Cr. H.)

This course tackles the meaning of scientific manner, its importance for academic research, the general manners and styles of research, the conditions of the research in jurisprudence and its foundations, the practical ways to achieve the research, the edition styles, the scope of research in jurisprudence, and the best authentication way in such research.

0402453 Comparative Jurisprudence

(3 Cr. Hrs.)

The course deals with the introduction to comparative Jurisprudence; reasons of disagreement and agreement among Fiqh Scholars. Ijtihad (Rule Deduction or reasoning): definition, conditions, status. Imitation: definition, transfer from one doctrine to another. Ifta' (Passing Judgments): properties of Mufti.

0402463 Reasoning, Imitation, Contradiction and Preference (previous req. 0402161),

(3 Cr. Hrs.)

This course includes these subjects to be discussed from the books of the foundations of jurisprudence: reasoning, imitation, contradiction and preference.

0402464 Takhrij al-Fura<sup>c</sup> cala Usul (i.e. referring the legal rulings to their foundations) (3 Cr. Hrs.)

This course sheds light on the disagreement in the legal rulings and its reasons, a brief study to the most important maxims of usul al-Fiqh (i.e. principles of Islamic jurisprudence), the consequences of the disagreement in these maxims on causing disagreement in the legal rulings, the legal maxims which relate to the ways of the meaning of the expressions, the maxims which concern the meaning of the expressions in terms of being comprehensive and not, the maxims of command and forbid, the maxims which relate to the noble Qur'an and their impact on the legal rulings, the maxims which relate to the Sunnah and their impact on the legal rulings, the consensus and analogy and their effect on the legal rulings, and the sources of Islamic jurisprudence in which there is a disagreement between the scholars and the consequences of this agreement on the legal rulings.

0401111 Our'anic Sciences

(3 Credit Hours)

This course includes identification of the Holy Qur'an with concentration on all of aspects related to its descent as well as the reasons for that whether in Makki Chapters (Sura) or in Madani Chapters (Sura) in addition to its illustration, scripting and translation of the Holy Qur'an, the Miracle of the Holy Qur'an, its precise, similarity, copier and copied, maintaining, integrity of distortion, alteration, eliminating any obscurity against it, readings, readers of the Holy Qur'an and fundamentals that must be taken into account in its interpretation.







0401112 Recitation and Memorization /1 (One Theoretical Hour & Two practical hours)

This course includes the study of the following subjects: Isti'aazthah ("I seek refuge in Allah from the accursed Shaytaan"), Basmalah ("In the name of Allah, the Most Gracious, the Most Merciful"), Ruling of "N" Saakinah consonant (With Sukoon), Tanween (Doubling the vowel), "M" Saakinah Consonant and Mumdood (lengthening of the sound), Qalqalah (Rebound of the sound) with the recitation of parts of 23-30 from the Holy Qur'an (YaSin Chapter to last of the Holy Qur'an ), besides memorization of the two sections 29 and 30 in addition to the practical application of the recitation of the required parts under the supervision and follow-up of the course professor.

0401121 Hadith (Prophetic Sayings) Sciences

(3 Credit Hours)

This course includes the study of all Hadith (Prophetic Sayings) Sciences as follows: Status of Sunnah, Hadith (Prophetic Sayings) narratives and its script, narrator's sciences, text sciences, Hadith original sources sciences, narratives differences, acceptable and rejected from Hadith where two books of Hadith (Prophetic Sayings) Sciences have to be taught in this course in which one of them is old while the other one is contemporary specifically, "Criticism Methodology in Hadith (Prophetic Sayings) Sciences.

0431122 Hadith Authentication & the Study of Chains (previous reg. 0401121)

(3 Cr. Hrs.)

This course consists of a study of the books of sunna; how to find Hadiths in these classified books; evaluating the hadiths, books of narrative, and books of Hadith; the course also deals with the definition of scientific research, its bases and procedures, and how to edit manuscripts of Hadiths

0431123 Biography of the Prophet

(3 Credit Hours)

This course concentrates on all biography events of the Prophet (peace be upon him) from his birth until his passing away and joining the Comrade Almighty Allah. This is an analytical study of devising lessons, examples as well as comparing it to reality today with a focus on the foundations of the Muslim community and the statement of the characteristics of Biography of the Prophet and composition of the ancient and contemporary curricula. Besides rational interpretation of history and benefiting from the Prophet Sunnah (Ways of doing matters) (peace be upon him) in dealing with problems, utilizing them to address the causes of problems nowadays for progress and modernization.

#### 0401132 Origins of Belief

(3 Credit Hours)

This course aims to introduce students to the overall principles of belief and its pillars which includes the study of the concept of religion pedagogy, its synonyms, the date of its inception, development, its objectives, its evaluation and terminology of schools, and the characteristics of the Islamic faith, its components and the methodology of the Q'uran in the display, it also addresses definition of science, sections of perception, ratification, inference, measurement types, forms, methods of knowledge creed evidence of mental and audio, it also addresses the issue of faith, truth, various related subjects, it discusses faith that God exists and sections of unification, evidence and some of its manifestations with a brief idea about origin of fatalism, it also concentrates on the continued faith in the unseen as well as the angels.

### 0431213 Recitation and Memorization /2 (One Theoretical Hour & Two practical hours) Prerequisite (0401112)

This course includes the study of the following subjects: Letters articulations and its characteristics, emphatic pronunciation, attenuation and aggrandizement with the recitation of the first ten parts of the Holy Qur'an (Al-Fatihah, The Opening to last of The Repentance Chapter) along with memorization of two sections 27 and 28 with the practical application of the recitation of the required parts under the supervision and follow-up of the professor.

### 0431314 Recitation and Memorization /3 (One Theoretical Hour & Two practical hours) Prerequisite (0401213)

This course includes the study of the following subjects: Diphthong, , writing pausing , commencement with all its branches and how to weaken the sound movement, lips occlusion (Voiceless Pronunciation), connecting a glottal Stop (Hamzah), Noun division, relative pronoun, feminine noun ending with "T" besides concentration on certain grammatical rules exceptional words with the recitation the Holy Qur'an starting from beginning of "Yunus Chapter" to "YaSin Chapter" besides memorization of the two sections 26 and 25 in addition to the practical application of the recitation of the required parts under the supervision and follow-up of professor.

#### 0452212 Jurisprudence of Alms and Pilgrimage

(3 Credit Hours)

This course studies the rulings of jurisprudence of Alms (obligatory charity); its concept, legislation, conditions, kinds of wealth in which alms is obligatory, the relationship between alms and taxation, ways of distributing alms. The course also discusses the Jurisprudence of Hajj (pilgrimage): its concept, legislation and rules. This covers its time, kinds of Hajj, how to perform hajj on behalf of others, and the rulings of Umrah (minor pilgrimage).

0401211 Exegesis

(3 Cr. Hrs.)

This course aims to give the student an idea about the principles of exegesis the concern of the Qur'an in the principles of belief and their effect on the establishment of the society. The exegesis of Sections: 29 and 30 is a requirement of the course, in addition to the meanings of certain vocabularies of the second half of the Qur'an.

#### 0401222 Analytic Hadith

(3 Cr. Hrs.)

This course aims to discuss certain accounts of the Prophet from different aspects such as: their meanings, ascriptions (chain), and words from the following books:

- O Sahih al-Bukhari with Fath al-Bari, 15 accounts from the following chapters: (Bad' al-Wahy, al-'Ilm, al-'Umrah and Khabar al-'Ahad).
- Sahih Muslim with Sharh al-Nawawi, 15 accounts from the following chapters: (al-Iman, al-Jihad wa al-Imarah, al-Libas wa al-Zinah and Sifat al-Munafiqin).
- o Al-Sunan al-Arba'ah and Musnad al-Imam Ahmad, 20 selected accounts.
  - All this in addition to other positions to be read by the student himself from the previous books.

#### 0401231 The Creed (Prophicy, Angles, Holy Books and the Hereafter)

(3 Cr. Hrs.)

The course discusses special topics in the Islamic creed such as: prophets, Messengers, holy Books; the Hereafter, revelation, miracles, infallibility of prophets, belief in the holy Books, signs of the Hereafter, and scenes of the Hereafter; the evidences of the resurrection and refuting accusations on it.

#### 0401404 Islamic Studies in English

(3 Cr. Hrs.)

This course aims to give the students the most important vocabularies in Islamic scholarship; particularly those of Islamic Call, Creed, Jurisprudence and its Foundtions, in order to enable the student to deal with Islamic books in English. The course also includes a discussions of texts from the Qur'an, Hadith books, ancient and contemporary books and books of Oriantalists.

#### 0401202 The Biography Of The Rightly-Guided Caliphs

(3 Cr. Hrs.)

This course highlights the most important events and developments in political administration and military both domestic and foreign affairs of the Islamic state. It addresses the issue of haw can we make benefit of these events in our contemporary time by analyzing the methodology of every caliph in implementing Islam.

#### 0401223 Prophetic Guidance in Morals, Decorum and pity

(3 Cr. Hrs.)

The course includes a discussion of nearly 20 of the prophet's accounts in Sahih al-Bukhari from the chapter deals with the prophetic guidence in decorum and pity, also selected accounts should be studied from Sahih Muslim. The course aims to give the student a good information of the Prophet's directions, and advices to his followers.

0401234 The Foundations of Oration & Call

(3 Cr. H.)

This course discusses the main issues of Islamic Call, such as: The meaning of Islamic Call, its characteristics, rules and importance. This includes: The Caller and his role, the rights of those whom are called, how to assure their faith and morals, an applied study to the main styles of the Call, such as delivering the speech of Jumu'ah, and other circles and lectures which eventually form the best preachers and callers.

0401412 Exegetes' Manners

(3 Cr. Hrs.)

This course aims to give a general introduction to the sources of exegesis, methods and styles of exegetes in their books of exegesis, difference between exegesis an interpretation; types of exegesis, characteristics of every school of exegesis, the best way of explaining the Qur'an, the development of exegesis in recent time.
