**Title and abstract of the doctoral thesis (within 150 words)****The Concept of Conflicting Hadith/ *Mukhtalif al-Ḥadīh* in *Ḥadīth* Scholarship:****A Study of Ibn Qutaybah's Book Interpretation of Conflicting Hadith *Ta'wīl Mukhtalif al-Ḥadīth***

The thesis investigates the concept of *mukhtalif al-ḥadīth* in *ḥadīth* scholarship.

This is with focus on its relationship to *‘ulūm al-ḥadīth* in general and to the practice of *naqd al-matn* in particular. The thesis also attempts to present an assessment of the third century of *Hijra* scholar and *qāḍī* Abū Muḥammad ‘Abd Allāh ibn Muslim Ibn Qutaybah al-Dīnawarī's contribution to the subject in his celebrated work *Ta'wīl mukhtalif al-ḥadīth*. This thesis is divided into five chapters followed by a Conclusion and Bibliography. The first chapter is an introduction to the work. Chapter two investigates the concept of *mukhtalif al-ḥadīth* and the interest in *naqd al-matn* in *ḥadīth* scholarship. The third chapter presents the biography of Ibn Qutaybah and a brief account about his time and works. In chapter four we explore Ibn Qutaybah's book, its name, main characteristics, the author's style and references. Chapter five is an assessment of Ibn Qutaybah's contribution to the field. This chapter is divided into two parts. The first talks about Ibn Qutaybah's work and *‘ulūm al-ḥadīth*. The second part talks about Ibn Qutaybah's use of *uṣūl al-fiqh*. The conclusion summarises the most important findings of the thesis.
