Determent in the Holy Quraan

This study entitled "the Method of Determent in the Holy Qoran" aimed at identifying this distinctive Qoranic Method from its varied aspects. Having defined the terms of Method and determent linguistically and technically, the study concluded that the Method of determent is a missionary one used by the Holy Qoran intimidating from deviation from Allah's orders, and preventing violations, so that human happiness can be realized in this and hereinafter days. Deterring words were "Kalla, and ma Kana" that are the two words cited in the deterring Qoranic verses. Another type of determent is exemplifying by the destiny of old nations with its characteristics being totality, equality, heterogeneity, supremacy of the mission, and gradualism. I made converged the seemingly diverged areas of determent. From one hand there was deterring from disobeying Allah, as, for example, the deceptiveness of generosity leading to denying graces, and deceptiveness of a respite leading to dare committing disobedience, and from the other hand deterring from insulting the Prophet "may Allah blesses him" and believers, and deterring from being occupied by the mundane life more than the Hereinafter. The study addressed such kinds of people deterred by the Holy Qoran including believers and disbelievers so that they would be prevented from doing things that otherwise would expose them to peril and damage in this mundane life and rewarding them punishment in the Last Day.
