Likewise, the legal policy enters into what is not stipulated in it, because what is not stipulated in it, comes under the section of ijtiḥad, and the legal policy of ijtiḥad, and the legal policy is the justice of God and His Messenger, and it is a measure of the matter in what works for it, so its aim is justice and interest and it revolves in their astronomy.
