

Faculity of Shari'a Master in Hadith

0431731 Hadith Sciences

(3 credit Hours)

This course discusses deeply the most important Hadith issues such as the analytical study for the basis of this science, highlighting and discussing the scholars' special terms both in terms of subject classification and authenticity classification. This is done through academic critique towards text and chain of narrators of Hadith. Hadith.

0441732 Methodologies of Scholars of Hadith

(3 credit Hours)

This course discusses the methodologies which have been adapted by Hadith scholars when they classified the Hadith narrations in addition to historical development in writing in this science. It highlights the efforts of these scholars in collecting and preserving these narrations from being lost. It demonstrates as well, the hot issues in which researchers of this field have to tackle in this modern time.

0451733 Hadith Narrators

(3 credit Hours)

This course tackles the manners followed by Hadith scholars in classifying Hadith narrators, in terms of their names, descend ship, nicknames, date of birth, names of teachers and students, scientific journeys, viewpoints of scholars towards them. It tackles as well, how scholars manage to adapt a standpoint towards theses narrators in terms of acceptance and refusal.

0441734 Rules of the Judgment on Hadith

(3 credit Hours)

This course shows the rules in which scholars has invented to study and critique narrations of Hadith, through highlighting the basis and restrictions upon which scholars distinguish between authentic and false Hadiths.

It tackles as well how to guide and direct the student to the right application for theses rules and restrictions when dealing with the Hadith narrations.

0441735 Rules of Research and editing

(3 credit Hours)

This course highlights the fundamental rules of academic research methods. The preconditions in which researcher must fulfill, the characteristics of the good academic research.

It covers as well the rules of manuscripts' editing in terms of publishing them in an acceptable form and in terms of the rules of how to confirm the attribution of a certain book to its author.

0431736 Analytic Hadith

(3 credit Hours)

An analytic study will be paid to the expressions and explanations of certain Hadiths selected from famous Hadith Books, the study will also cover what can be resulted from these Hadiths as rules and faith matters.

0441737 Mukhtalaf Al- Hadith

(3 credit Hours)

This course deals with the meaning of Mukhtalaf al-Hadith (what appears contradicted superficially) its reasons, methods of clarifying this obscurity, the development of this science, and its most important sources. The course will concentrate also on an applied study to certain obscure Hadiths in details.

0431738 'Ilal al-Hadith

(3 credit Hours)

This course deals with the science of 'ilal (the unclear hidden problematic defects of the narration) by giving its definition, history, development, bases, procedures of knowing the 'llah, and the main sources of this science.

0431742 Language in Hadith

(3 credit Hours)

This course deals in depth with the prophetic sayings from linguistic viewpoint by dealing with the ancient authentic linguistic resources which have been concerned in this issue.

0441743 Scientific Inimitability in the Qur'an and Sunnah

(3 credit Hours)

This course investigates and discusses the scientific facts in which Qur'an and Sunnah have pointed out to, long time ago in different scientific areas.

It is highly recommended in this course that the students should study in the introduction the standpoint of contemporary scholars towards this issue. In specific student should have a look at the production of the "specialized council in scientific inimitability of the Qur'an and Sunnah".

0441744 Thematic Hadith

(3 credit Hours)

This course deals with certain subjects by collecting Hadith concerning them, then to edit these Hadiths by giving their sources and degrees (according to Hadith sciences), then to arrange these Hadiths in the same subject, and finally to give the conclusion to each Hadith subject.

0401746 The Sunnah in Contemporary Studies

(3 credit Hours)

This course deals with the Scholars' efforts and manners in all Hadith sources and encyclopedias, and the development of encyclopedically classification until modern encyclopedias, which use computer systems.

0441709 Verses of Legal Rulings

(3 credit Hours)

This course deals with the legislative verses of the Qur'an as referred to/in Islamic resources both the original and the contemporary ones. The course also deal with the importance of this type of knowledge and methodologies of deducing the rulings from the Qur'an and the difference between exegesis of jurisprudence and legislative verses. Also, the course deals with exegete's opinions and their methodology in directing and explaining this sort of verses.

0432712 Objectives of Islamic Shari' a

(3 credit Hours)

This course is devoted to study the objectives of Islamic legislation, as knowing these objectives is an important requirement for understanding the religious texts and deriving rulings from them. However, the main objective of Islamic legislation is to satisfy the interests of the people and to protect them from the evils. Besides, there are other objectives of Islamic legislation, such as meeting mercy and justice, the restricted interest, and justifying the legal rulings by interest. Moreover, it covers the interests of the servants which are divided into three categories. 1. Al-Dharuriyyat, the necessities or the necessary interests. 2. Al-Hajiyyat, the utilitarian interests. 3. Al-Tahsiniyyat, the embellished or secondary interests. Thus, it studies the concept of these three types of interests, some of their examples, and the rulings legislated for meeting them. Besides, it concentrates on assessing the five issues the protection of which is considered as being the foundation of the interests of the people i.e. religion, human soul (life), mind, progeny and property. It sheds light also on several relevant subjects, such as the order of the legal rulings according to their objectives, commanding in Islamic Shari'a comes only with the possible rulings, and the prohibition level differentiates according to the variety of the level of the harm which the unlawful deed causes.


