



## COURSES DESCRIPTION Ph. D in Hadith

### 0401921 Studies in the Foundations of Hadith

(3 credit Hours)

This course deals in depth with specific important subjects and terms in the foundations of Hadith in terms of studying, analyzing and criticizing different viewpoints in this regard.

It concentrates on the scientific justification for the applied criteria to distinguish between authentic and unauthentic narrations.

## 0401922 Studies in Ilal Al- Hadith

(3 credit Hours)

This course discusses deeply objective researches in the science of Illal (the hidden problems either in the chain of narrators or the text of the Hadith) it highlights the different schools of thought or methodologies of scholars in this regard.

## 0401923 Al – Jarh wa al – Ta'dil (Declaring Unreliable and Improvement)

(3 credit Hours)

In this course there will be a study to Hadith Relaters in accordance to their classifications, and the Chains of the Hadiths, whether they are connected or not. This course discusses the bases of the science of al-Jarh wa al-Ta'dil, its terms, and an applied study to Hadith Narrators.

## 0401924 Critiqued Narrations in the Two Authentic Hadith Books (Buklari and Muslim) (3 credit Hours)

This study deals with the reasons which made some of the scholars criticize some of Hadiths in *Bukhari* and *Muslim* and how to deal with them.

## 0401925 Hadith Jurisprudence

(3 credit Hours)

This course deals with a study to the best way of understanding Hadiths, the rules and conditions of this understanding, and then and applied study to some chose Hadiths in order to show the errors occurred in understanding Hadiths.

## 0401926 Textual studies on Hadith Books

(3 credit Hours)

This course discusses certain pages in Hadith books in order that the student can refer to them and understand them easily.

### 0401927 Studies in Hadith Manners

(3 credit Hours)

This course aims to give the student a practice al knowledge in studying Hadith Manners, what main Hadith Scholars have followed in choosing accounts, editing accounts, their manners in classifying fabricated accounts and their criteria in this matter.

### Studies in prophet's campaigns (maghazi) Books

(3 credit Hours)

This course is concerned in how did this special field of study start and the different methodologies in composing within it. It concentrates on studying the narrations related to the prophet's battles from the authentic sources.

## 0401929 Ah

## **Ahadith of Legislations**

(3 credit Hours)

This course deals with the evidences, upon which Islamic legislations have been built on, in the prophetic sayings. It is expected that this course will be the connection thread between the science of Hadith and the science of Islamic Jurisprudence.

## Ma'thor Exegesis

(3 credit Hours)

This course deals with what is known as "ma'thor Exegesis" i.e. the traditional way of interpreting the meanings of the Qur'an according to the sound authentic prophetic sayings. It discusses the definition, the importance, and the historical roots.

## 0401931

## The schools of Hadith

(3 credit Hours)

This course studies some of Hadith schools (like Al Higaz, Basra, Kofa ... Schools). It highlights the basic elements and characteristics of each school, their scientific methodologies, their efforts in classifying the prophetic narrations, the impact of these schools and their role in the development of the science of Hadith.

## 0401932

## Hadith and the Rational School

(3 credit Hours)

This course focuses on the relation between Hadith as a divine revealed text and the human rational as a tool to understand this text.

## 0401933

## Hadith and its sciences amongst Muslim sects

(3 credit Hours)

This course discusses the opinions of some Muslim sects regarding narrations of the Hadith, how these narrations should be criticized, their rules and principles upon which they depend and finally investigating their resources for analyzing and criticism to highlight the impact of theses opinions on the debate and dispute in the fields of faith and jurisprudence.

## Abrogation in Hadith (Nasekh wal Mansoukh)

(3 credit Hours)

This course investigates the whole issue of and abrogation within the science of Hadith. The importance of this science, its historical development, the most well-known narrators in this regard, studying samples from these Hadiths then trying to discover the connecting thread between these Ahadith and the other Qur'anic verses and other prophetic sayings.

### Reformation in Hadith Sciences

(3 credit Hours)

This course aims to discuss certain issues regarding Hadith Sciences, whether in chain or text, it urges the students to contribute in finding new fields and thoughts in studying Hadith in order to comply with the needs of the new era.

(3 credit Hours)




